

## **Carsome Big RM88 Sale: Terms & Conditions**

- This campaign will run from August 11, 2021 ("Commencement Date") to August 31, 2021, both dates inclusive ("Campaign Period"). Carsome Sdn Bhd (201401025864) ("Carsome") reserves the right to shorten or extend the Campaign Period without prior notice.
- 2. This campaign shall be applicable for the purchase of used vehicles sold by Carsome on Carsome's platform at <a href="https://www.carsome.my">www.carsome.my</a> during the Campaign Period ("Vehicle"). This Promotion will not be valid for the purchase of vehicles marked as Partner Cars or new vehicles.
- 3. The customer will only need to pay Ringgit Malaysia Eighty-Eight (RM88.00) per month for the first three (3) months of the hire purchase loan instalment repayment obtained from all credit companies and banks for the purchase of the Vehicle ("Promotion").
- 4. This Promotion will only be available to customers that apply for hire purchase loans ("Loan") with a loan tenure of minimum five (5) years and shall be subject to the approval of the Loan from credit companies and banks.
