

Terms & Conditions

1. The campaign will run from November 25, 2021 (“Commencement Date”) to February 25, 2022, both dates inclusive (“Campaign Period”). Carsome Sdn Bhd (201401025864) (“Carsome”) reserves the right to shorten or extend the Campaign Period without prior notice.
2. This campaign is only applicable to Mah Sing residential property owners with the M Privilege membership loyalty programme (“Participant”).
3. This campaign shall be applicable for the purchase of used vehicles sold by Carsome on Carsome’s platform at www.carsome.my during the Campaign Period, including discounted vehicles (“Vehicle”). This campaign will not be valid for the purchase of vehicles marked as Partner Cars or new vehicles.
4. For every Vehicle purchase, Participant will be entitled to the following Extra Benefits:
 - (a) Free Upgrade to Platinum Extended Warranty Program worth up to RM1,400; and
